LCFF Budget Overview for Parents (BOP) was approved by Site Council in December, and we needed to bring it back with minimal updates. In December we had the numbers for what 2020/21 budget was supposed to be, should have been done last June but with COVID it was pushed back six months. This year we are talking about what happened in 2020/21 for budget purposes. The BOP has been translated and our ELAC families have reviewed it and it is also on the school website. Our objective is to close the achievement gap within three years.

Local Control and Accountability Plan (LCAP) Annual update for 2019/20 and then 2020/21, this has figures of what we thought we would do and what we did. Purple is the first year of 2019/20 and green is the 2020/21, we were able to put data behind that and spent time talking about successes and areas of need. Our gap for English Learners widened during COVID (distance learning), with additional support staff well start closing the achievement gap. TRCS will close the achievement gap within three years; ninety percent of students proficient.

3. Budget-First Read

2020/21 estimated actuals were presented showing a large increase to restricted federal and state funding that will be spent over the next two to five years according to plans. 2021/22 budget was presented using an estimated ADA of 450.90. COLA for the 2021/22 is projected to be 5.07%, this is a drastic difference from COLA just one year ago. 2021/22 unrestricted budget shows an expected increase to ending fund balance of \$10,050 and a planned spending down of restricted fund balance in the amount of \$278,654. Multi-year projections show increase to unrestricted ending fund balance and continued planned spending down of restricted fund balance.
